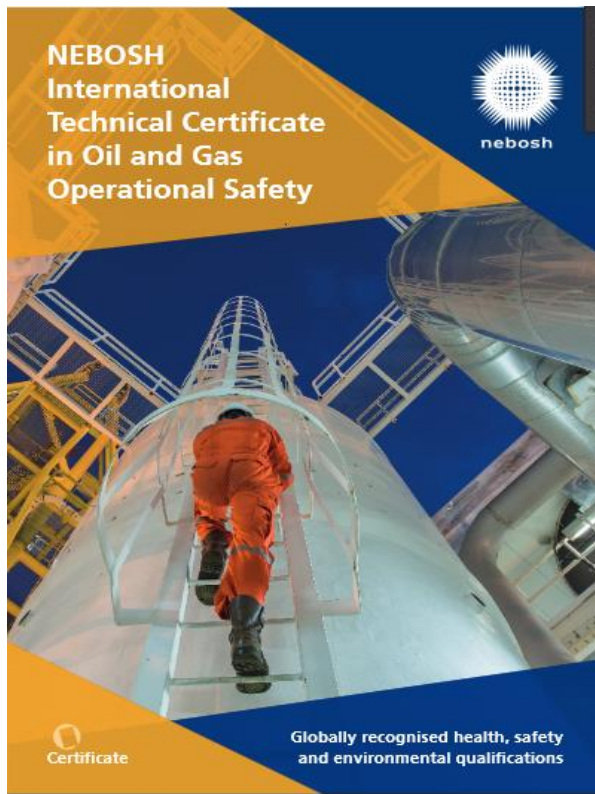

## **The NEBOSH International Oil & Gas Certificate – IOGC**

**The NEBOSH Technical Certificate in Oil and Gas Operational Safety covers one main unit (IOG1) entitled ‘Management of International Oil and Gas Operational Safety’.**

The International Oil and Gas Certificate is aimed primarily at managers, supervisors and health and safety advisers with safety responsibilities in the oil and gas industry. The qualification focuses on operational process safety and is intended to enable learners to apply and implement effective process safety management across all areas of their operation, anywhere in the world.

This qualification provides the underpinning knowledge, which when combined with experience enables holders to identify, evaluate and control a wide range of workplaces hazards. It is based around international standards and management systems that enable the effective discharge of workplace safety responsibilities both onshore and offshore. Globally, employers in the oil and gas industries find that the International Oil and Gas Certificate can improve the safety culture of their organisation by providing line management and staff with a sound understanding of operational safety management. Our qualifications are developed based on extensive research with health and safety professionals, employers, professional bodies, and regulators to ensure that they remain relevant, rigorous as well as achievable and practical. You will be assessed on your ability to apply your skills and knowledge to a wide range of issues and how to deliver positive change to a real workplace.

## The key topics covered by the qualification are:

- Hazards inherent in the extraction, storage and processing of raw materials and products
- Hydrocarbon process safety
- Risk management techniques used in the oil and gas industries
- Contractor management
- Fire and explosion controls in the oil and gas industries
- Marine and Land logistics

## Syllabus

### This unit is divided into the following five key elements:

- E1 - Health, safety, and environmental management in context
- E2 - Hydrocarbon process safety (1)
- E3 - Hydrocarbon process safety (2)
- E4 - Fire protection and emergency response
- E5 - Logistics and transport operations



NEBOSH does not set specific formal entry requirements for this qualification. However it should be noted that: The achievement of the NEBOSH International or National General Certificate in Occupational Health and Safety or equivalent prior to undertaking the International Technical Certificate in Oil and Gas Operational Safety course is highly recommended.

#### Individuals

People from all around the world who are working in the oil and gas (or related) industries, who need to gain a sound understanding of the principles of operational health and safety that apply in their specialist area. For some, the International Oil and Gas Certificate can be an important step towards establishing a lifelong professional career in occupational health and safety. Some who take their International Oil and Gas Certificate progress on to one of our Diploma level qualifications.

NEBOSH strongly recommend that you should already have an underpinning knowledge of health and safety issues prior to taking the course equivalent to the NEBOSH International or National General Certificate in Occupational Health and Safety.

## **Employers**

Quite simply, the International Oil and Gas Certificate is a qualification that should lead to safer workplaces. People who hold this qualification understand their responsibilities and how to reduce potentially damaging incidents that can lead to loss of life, injury, and loss of reputation, wherever they are operating in the world. NEBOSH qualifications are held in high esteem throughout the world. Employing people who hold a NEBOSH qualification demonstrates a commitment to health and safety and an assurance to others. It can even help you achieve recognised standards and win new business. It is based around international standards and best practice recommendations.

## **What are the Course Entry requirements?**

There are no entry requirements for this qualification, but we do recommend that learners have an underpinning knowledge of safety issues. This may have been achieved by studying a NEBOSH General Certificate level qualification. It is also important that learners have a suitable standard of English language to understand and articulate the concepts contained in the syllabus.

NEBOSH recommends that learners undertaking this qualification should reach a minimum standard of English equivalent to an International English Language Testing System (IELTS) score of 6.0 or higher in IELTS tests.

## **What is the duration of the course?**

The course is five days tuition and then 1 day for an examination which is 2 hours duration.

## **Is the NEBOSH International Oil & Gas Certificate a recognised qualification?**

### **Professional recognition and SQA Accreditation / Maintaining Professional Standards**

In the UK – and, increasingly, worldwide – regulatory accreditation is recognised as a badge of quality, meets specific quality criteria that ensure it is fit for its purpose:

- Includes relevant content
- Uses appropriate assessment methodology
- Is mapped to relevant National Occupational Standards (NOS)
- Is supported by relevant stakeholders including employers

## **How is Valued by Employers?**

## **How is the course assessed?**

Students are assessed by one two-hour written examination. The examination consists of ten 'short-answer' questions and one 'long-answer' question /an invigilated paper-based exam totally 11 Questions). Scripts are marked by competent external examiners appointed by NEBOSH. The overall qualification parchment will be issued on successful completion of the qualification.

## **Certification**

A certificate is issued denoting successful achievement of the exam.



### Resits

If any learner wants to do a re-sit exam following a referral, they can apply for this, and resit the examination on the next available date. The learner can if they wish sit on a scheduled revision day if they feel is necessary to help them. Please note that there is a charge for this.
